

# “Big Feast” Giveaway 2024

## Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Contest is open only to those who sign up at the participating businesses and who are 18 as of the date of entry. The contest is only open to legal residents of Logan County, and is void where prohibited by law. Employees of Northeast Colorado Broadcasting, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the contest. The contest is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

2. Agreement to Rules: By participating, the Contestant (“You”) agrees to be fully and unconditionally bound by these Rules, and You represent and warrant that you meet the eligibility requirements. In addition, You agree to accept the decisions of Northeast Colorado Broadcasting as final and binding as it relates to the content of this contest.

3. Contest Period: Entries will be accepted at participating businesses starting November 1, 2024 and ending on November 21, 2024. All entries must be received by close of business on November 21, 2024.

4. How to Enter: The participant must enter by submitting an entry slip provided at participating businesses. The entry must fulfill all contest requirements, as specified, to be eligible to win a prize. (First and last name, phone number, date of entry). Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Northeast Colorado Broadcasting.: You may enter only once per day at each participating business. You must provide the information requested. You may not enter more times than indicated by using multiple identities, in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, any submissions by you may be removed from the contest at the sole discretion of Northeast Colorado Broadcasting.

5. Prizes: The Winner of the contest (the “Winner”) will receive a Thanksgiving "Feast" that will feed up to 6 people and will be provided by Hootenannies in Sterling, Colorado. Actual/appraised value is \$200.00. The Winner of the contest will pick up a certificate at the KPMX studios at 117 Main that must be presented at Hootenannies as specified in these rules to claim the Thanksgiving “Feast.” The specifics of

the prize shall be solely determined by Northeast Colorado Broadcasting. No cash or other prize substitution shall be permitted. The prize is non transferable. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of Winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted. Acceptance of prize constitutes permission for Northeast Colorado Broadcasting to use Winner's name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.

6. Odds: The odds of winning depend on the number of eligible entries received.

7. Winner Selection and Notification: Winner will be selected by drawing on November 22, 2024, under the supervision of Northeast Colorado Broadcasting. Winner will be notified by phone and the winner will be announced live on air the day of the drawing. Northeast Colorado Broadcasting shall have no liability for Winner's provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, entry is ineligible, fails to claim the certificate at the KPMX Studios by November 26 at 3 pm, or fails to present the certificate to Hootenannies in Sterling, Colorado between the hours of 11 am and 1pm on November 28, 2024 (Thanksgiving) the prize may be forfeited and an alternate Winner may be selected. The Winner will receive a certificate that must be picked up at KPMX Studios, 117 Main Street, Sterling, Colorado by November 26, 2024 at 3pm. The Certificate must be presented at Hootenannies, 324 W Main St., Sterling, Colorado on November 28, 2024 between the hours of 11 am and 1pm. If the winner fails to pick up the "Feast" from Hootenannies between the hours of 11 am -1 pm on November 28th, the prize may not be awarded. Receipt by Winner of the prize offered in this contest is conditioned upon compliance with any and all federal, state, and local laws and regulations. Terms & Conditions: Northeast Colorado Broadcasting reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the contest should virus, bug, non-authorized human intervention, fraud, or other cause beyond Northeast Colorado Broadcasting's control corrupt or affect the

administration, security, fairness, or proper conduct of the contest.. In such a case, Northeast Colorado Broadcasting may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by Northeast Colorado Broadcasting. Northeast Colorado Broadcasting reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the contest or violates these Terms & Conditions. Any attempt by an entrant to deliberately damage or undermine the legitimate operation of the contest may be a violation of criminal and civil laws. Should such an attempt be made, Northeast Colorado Broadcasting reserves the right to seek damages to the fullest extent permitted by law.

Limitation of Liability: By entering, You agree to release and hold harmless Northeast Colorado Broadcasting and its subsidiaries, affiliates, advertising and promotion agencies, partners, representatives, agents, successors, assigns, employees, officers, and directors from any liability, illness, injury, death, loss, litigation, claim, or damage that may occur, directly or indirectly, whether caused by negligence or not, from: (i) such entrant's participation in the contest and/or his/her acceptance, possession, use, or misuse of any prize or any portion thereof; electronic or human error in the administration of the Promotion or the processing of entries.

Disputes:As a condition of participating in this contest, the participant agrees that any and all disputes that cannot be resolved between the parties, and causes of action arising out of or connected with this contest, shall be resolved individually, without resort to any form of class action, exclusively before a court located in Colorado having jurisdiction. ## **CONTEST RULES**

1. No purchase is necessary to participate in or win any Northeast Colorado Broadcasting (NCB) contest.
2. By participating in a contest you agree to these rules. Decisions by NCB regarding winners and interpretation and administration of contest rules and details are final.
3. Contests are open to NCB listeners 18 years of age and older, except as follows:
  - A. There may only be one winner per household of a NCB contest in any 30-day period.
  - B. If a member of a household wins a prize valued at \$1,000 or more, no member of that household may win another prize valued at \$1,000 or more within the next 12 months.
  - C. A household may only participate in any NCB contest once per day.
  - D. Current and former employees of Northeast Colorado Broadcasting, interns, contractors, agents, and employees of participating sponsors, promotional partners or advertising agencies and of other broadcast companies, and their immediate family members and/or household members are not eligible for any contest.
4. Contest entries will only be accepted in the manner and at the times announced for each contest. NCB is not responsible for contest entries that are not received for any reason. Entries are the property of NCB. If an entry is illegible or cannot be understood, or does not supply all required information, the entry will be considered invalid.
5. When requested a contestant must disclose his or her legal name, address, telephone number and Social Security number and show legal ID. Winners may be required to sign tax forms, affidavit of eligibility and/or release. If the requested information or signatures are not provided or information given is untrue, contestant or winner may be disqualified.
6. Payment of taxes is the sole responsibility of prize winners.
7. Despite any inference or statements made at an event or on the air, a contestant is not officially a winner until NCB has determined that all eligibility requirements have been met and contest rules have been complied with.

These giveaways will involve a listener being the designated caller under the scheme announced on air or by correctly answering a question as determined by NCB and/or its employees, contractors or sponsors. Should there not be a winner under the scheme announced on air or a correct answer to the question given on air the stated prize will not be awarded at that time and may be awarded at a different time or in a different contest or not at all.

16. NCB reserves the right to change or amend these rules at any time.
