Rules

Official Contest Rules: KPMX & 94.5 The Ranch “Spring into Cha-Ching \$1000 Cash Giveaway”

1. **How to Enter**

Enter to win by visiting participating local businesses with official contest registration boxes. Fill out a registration slip completely and legibly with your full name and phone number. Incomplete or illegible entries may be disqualified.

2. **Entry Limits**

Only one (1) entry per person per business per day is allowed. Multiple entries beyond this limit may result in disqualification.

3. **Eligibility**

The contest is open only to residents of Logan County, Colorado and its adjacent counties who are 18 years of age or older at the time of entry. Employees of Northeast Colorado Broadcasting, LLC (including KPMX and 94.5 The Ranch), participating businesses, and their immediate family members are not eligible to win.

4. **Contest Period**

Entries will be accepted from May 1, 2026 through May 29, 2026. No entries will be accepted after this date.

5. **Selection of Finalists**

One (1) finalist will be randomly selected from each participating registration box after the contest period ends. Finalists will be contacted using the phone number provided on their entry form. In the event that a finalist cannot be reached within 24 hours, an alternate finalist will be drawn.

6. **Final Event & Grand Prize**

Finalists will be invited to a final event at a location, date, and time to be announced. Finalists will participate in games and/or activities to determine the Grand Prize winner of \$1,000 cash. The games and activities will be based on chance, and each game or activity will produce a winner. The Finalist who wins the most games and/or activities will be declared the Grand Prize winner. A Finalist does not need to be personally present at the final event to remain eligible for the Grand Prize; however, if a Finalist is unable to attend, they may designate a proxy to participate on their behalf. Any actions or results achieved by the designated proxy shall be binding and deemed the actions of the Finalist. If a

Finalist is not present and has not designated a proxy to participate in their place, the Finalist forfeits the opportunity to compete for the Grand Prize.

7. Prize Collection

Prizes must be collected in person at the Northeast Colorado Broadcasting office located at 117 Main Street, Sterling, Colorado.

8. Rule Changes & Alternate Entry Methods
